The White River Regional Solid Waste Management District Board of Directors is now accepting Pre-Applications for city or county supported recycling grant projects for 2022. Eligible categories include projects which address recycling, waste reduction and waste diversion needs.

Based on prior grant rounds we anticipate that the grants will continue to require a local cash match of 25% of the total project cost, so please plan for at least 25% of your project to come from local revenue.

This grant program reimburses 75% of approved project expenses, but only after your grant purchase has been made and a detailed invoice and cancelled check are submitted. Expenditures made prior to final grant approval cannot be reimbursed.

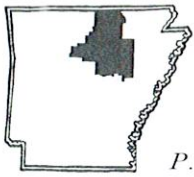
